	A.	CASH PRICE: The Consumer shall pay the Seller for the GenerLink Product selected above. Payment is expected prior to installation.

If the Consumer fails to pay any such bill within such twenty (20) of period, the Consumer will be charged a \$25 Late Fee. If the bill is not period, the Consumer will be charged a \$25 Late Fee. If the bill is not period, the Consumer will be charged the Generlink product hereunder giving ten (10) days' notice in writing to the Consumer.						
		If the GenerLink Unit is paid-in-full prior to the end of the 24-month period, the finance charge per month will be prorated.

### 3. INSTALLATION AND TERMINATION

A. INSTALLATION: The Consumer agrees to have Garkane install the GenerLink Product. Cost of installation is included in the price of the Unit. Consumer is responsible for purchase of their Generator and assumes all risk with such product – See Section 4 below for Generator information.

The Consumer is NOT allowed to install or uninstall the Generlink product. Only Garkane trained Technicians are allowed to install or un-install the GenerLink product.

B. TERMINATION: Should the contract be terminated by the Consumer, the Consumer agrees to pay Seller for costs associated with un-installing the GenerLink product.

In the event the Consumer sells their home, the Consumer must inform Garkane within 10 days prior to the closing of the sell of home. The Consumer may pay the balance owed on the GenerLink product or assign the balance to the new home owner (a new agreement must be signed by new home owner).

#### 4. GENERATOR INFORMATION

Consumer assumes all risk with purchase of Generators (please see "GenerLink<sup>TM</sup> And Your Generator" – Pages 5, 6, and 7 for information on Generator selection).

#### 5. TERM

This Agreement shall become effective as of the date this document is signed by the Seller and the Consumer.

Provided all payments provided for in Section 2A and/or 2B shall have been timely paid and all other obligations of the Consumer fulfilled as provided in all other portions of this contract and if no payments, late fees, connection, or related charges, or the interest thereon are delinquent then this Agreement shall terminate months/years from date product is made available.

However, in the event of a delinquency in any payment for which provision is made in this Agreement, interest shall accrue from the date per annum and until paid and all payments of principal shall survive this Agreement and the liability to pay such charges, interest and attorneys fees shall be enforceable by the Seller at any time.

#### 6. SUCCESSION

This Agreement shall be binding upon and inure to the benefit of the successors, heirs, legal representatives and assigns of the respective parties thereto.

## 7. <u>RULES AND REGULATIONS</u>

This Agreement shall be subject to Rules & regulations and rates as are, or may be in force as made by proper action of State Public Utility Commission having authority in area of service.
